

# ITEM Local Loop – Conditioning 110.50

#### 1. Service Description

Local Loop – Conditioning may be required in order to obtain the desired facility (line) characteristics for voice or analogue data transmissions.

The following types of conditioning are available:

Type	Required for
Analogue Data –	4 wire facilities, such as:
Schedule 4, Type 4/4A/4B/4C	<ul> <li>analogue data transmissions on a</li> </ul>
	dedicated voice grade facility.
Analogue Data – Type 2	2 wire facilities, such as:
	<ul> <li>analogue data transmissions on a</li> </ul>
	switched voice grade facility.
Voice	2 wire facilities, such as:
	<ul> <li>off-premise locals associated with PBX,</li> </ul>
	<ul> <li>off-premise network access associated</li> </ul>
	with key systems,
	• tie trunks,
	<ul> <li>off-premise extensions with the</li> </ul>
	SmartTouch features: Ident-A-Call or
	Intercom.

#### 2. Conditions of Service

- 1. For 4 wire facilities, customers must identify the type of conditioning required based on their type of equipment.
- 2. For 2 wire voice facilities, conditioning is required on the types of applications listed in the 'Types of Conditioning' table above and is applied once per channel.

#### 2. Conditions of Service - Continued

- 3. Bridging equipment is required when 2 or more legs (ie multi-drop) are connected (or bridged) to a main facility or leg.
- 4. The charge for bridging equipment applies for each leg (ie multi-drop) on a multi-point arrangement beyond the main facility or leg.
- 5. The charge for IX channel X-Connect applies once, in the rate center, for each connection of an analogue private line to another data service. These other data services may include a port on a shared Managed Digital Private Line Terminating Equipment (MDPLTE), a Packet Service access, etc.
- 6. All Local Loop Conditioning Services are provided subject to the availability of suitable facilities and equipment.

3. Rates

The Customer shall pay to SaskTel the following rates and charges for Local Loop – Conditioning. Such rates and charges are in addition to any other rates and charges that may be applicable.

The following table identifies how rates are applied for conditioning and bridging equipment:
