Voice Grade Facilities – Inter-Exchange

1. Service Description

Voice Grade Facilities - Inter-Exchange are communication paths with the bandwidth to carry telephone speech (or its equivalent). They connect two or more exchanges.

2. Conditions of Service

- 1. SaskTel does not guarantee DC continuity.
- 2. For a two-point channel the inter-exchange charge is based on the distance between the rate centres in which the originating and terminating service points are located.
- 3. For a multi-point channel the inter-exchange charge for each pair of exchanges is determined separately. The total charge is the sum of the charges for the lowest combination of rate distances that connect all points.
- 4. For a two point inter-exchange channel provided between a rate centre or SaskTel and a rate centre in the forty eight (48) contiguous states of the United States of America or the District of Columbia, the distance charge for the SaskTel portion is based on the measurement between the SaskTel rate centre and the applicable International border crossing which results in the lowest combined monthly charge.
- 5. A multi-point inter-exchange channel shall connect with a United States facility at the International border crossing point which results in the lowest combined monthly charge including the service points in Canada and the United States.

2. Conditions of Service — Continued

- 6. The link charge applies:
 - (a) once at each end of a point to point channel with one or more service points (drops) within the same exchange;
 - (b) once at each end of a pair of exchanges on a multi-point channel with one or more service points (drops) within the same exchange.
- 7. Inter-exchange rates apply per channel. The rate consists of a base charge plus a charge per mile for each mile (or portion thereof) for half-duplex or full-duplex service.
- 8. Full-duplex service requires two local channels per end.
- 9. Bridging equipment is required when 2 or more legs (ie multi-drop) are connected (or bridged) to a main facility or leg.

3. Rates

The Customer shall pay to SaskTel the following rates and charges for Voice Grade Facilities – Inter-Exchange. Such rates and charges are in addition to any other rates and charges that may be applicable.

The following rates and charges apply to Voice Grade Channels – Inter-Exchange within Saskatchewan and between Saskatchewan and the United States for link charges:
