2. Definitions

For the purposes of this Tariff Item:

"Company" refers to SaskTel.

"Emergency Services Agencies" refers to the public law enforcement, fire and ambulance services.

"Public Law Enforcement Agencies" refers to the federal, provincial and municipal police services as well as federal and provincial government departments who have the legislative authority to issue warrants and/or subpoenas.

"Private Line" refers to a non-network connecting voice communication service on a two-point or multi-point basis.
