1. Service Description

Local Loop Service - the facility is either between the demarcation point at a Customer's premise and the Customer's serving wire center/central office or between a wire center and a central office.

Basic Local Loop - provides a single communication path with the bandwidth to carry telephone speech (or its equivalent).

Basic Copper Local Loop - provides a single pair communication path with the bandwidth to carry telephone speech (or its equivalent), which guarantees metallic or DC continuity. *The Customer will receive a copy of the cable make-up, upon request.*

Enhanced Local Loop - provides a single pair, non-loaded, metallic facility. The electrical resistance of this facility will not exceed 1,300 ohms. *The Customer will receive a copy of the cable make-up, upon request.*

2. Conditions of Service

- 1. Local Loop Service
 - (a) These products are only available where suitable facilities exist.
 - (b) No term or quantity discounts are available for these products.
- 2. Basic Local Loop and Basic Copper Local Loop
 - (a) These products are available within or outside a Base Rate Area or Island Base Rate Area.

2. Conditions of Service – Continued

- (b) Rates and charges for the portion that extends beyond the base rate / island base rate area are *in addition* to the rates and charges for the main channel (i.e. the Basic Local Loop Facilities or Basic Copper Local Loop Facilities).
- (c) The monthly rental for the portion that extends beyond the base rate / island base rate is for each ¼ mile or fraction thereof, that the service is from the nearest point on the nearest base rate / island base rate area boundary.
- (d) SaskTel intends to install a transmission impediment on each of these loops that will effectively limit transmission to "voice band".
- (e) If no suitable facilities are available, the Customer will be required to pay SaskTel's total expense to provide such facilities.

3. Enhanced Local Loop

- (a) This product is only available within the boundary of a Base Rate Area or Island Base Rate Area.
- (b) If no suitable non-loaded, metallic facilities are available, the Customer will be required to pay SaskTel's total expense to provide such facilities.
- (c) Use of this product must comply with Industry Canada CS-03, T1-413, and other equivalent standards. When use of this product requires binder group separation or spectrum management, such use must be disclosed to SaskTel.
- (d) Use of this product must not:
 - Interfere with or impair service over any facilities of SaskTel,
 - Cause damage to SaskTel plant,
 - Impair the privacy of any communication carried over SaskTel facilities, or
 - Create hazards to SaskTel employees or the public.
